

POLICY/ROLES

COMPANY POLICY

Provides administrator additional controls to be set at the company level. These controls would apply to any role created. For example, the Company's approved ACH Payments limit is \$500,000. The admin would like to set a lower limit of \$400,000. The company policy allows the admin to set \$400,000 as the limit and no role can be created with an amount higher than the \$400,000 limit set at the company level.

ROLES

A user's roles define the permissions/tasks allowed within the role created. Roles are created and can be assigned to individual users or a group of users.

USERS

A user is an individual employee profile created in online banking. A user will need to be assigned to a role in order to operate within the online banking portal.

OVERVIEW

ACH COLLECTION

A commercial batch payment of several debits to the recipients' accounts and one large credit to the user's account.

ACH PASSTHRU

A commercial payment that allows users to import a single NACHA formatted file that contains multiple batches.

ACH PAYMENTS

A commercial batch payment of one large debit to the user's account and several credits into the recipients' accounts.

CHANGE ADDRESS

Allows users to submit a request to change their mailing address.

CHECK REORDER

Links user to vendor site to place new or reorder checks.

EFTPS

A commercial payment that allows users to pay their taxes using online banking.

STOP PAYMENT

Allows users to request a stop payment for an individual check that have not yet been presented for payment. Stop Payments submitted after 4:00 PM CT, 3:00 PM MT will be processed the following business day.

FUNDS TRANSFER

Allows users to move funds between the internal accounts they own and have access to in the online banking system.

WIRE-DOMESTIC

A commercial payment that allows users to originate a wire transfer to a recipient in the United States.

WIRE-INTERNATIONAL

A commercial payment that allows users to originate a wire transfer to a recipient internationally.

FEATURES**Rights****RECIPIENT UPLOAD FROM BATCH
(TREASURY ONLY)**

This feature determines if users can add new recipient records or update existing recipient records when uploading NACHA-compliant ACH files via the Pay & Transfer > ACH/Wire > New Payment > Upload From File workflow.

**WIRE UPLOAD FROM BATCH (REQUIRES
MULTI-WIRE)**

Users can upload multiple domestic and international wires via the Pay & Transfer > ACH/Wire > New Payment > Upload From File workflow.

**ALLOW ONE-TIME RECIPIENTS
CENTRIX ETMS (CENTRIX ETMS GROUP)**

Allows users to add a payment recipient without recording recipient details to the database for future use. Enables integrated access to the Positive Pay system to allow users to view and work Positive Pay exceptions on a mobile device.

VIEW WIRE ACTIVITY (TREASURY ONLY)

This feature determines if users can access the Wire Activity page to display incoming and outgoing wires, both domestic and international, regardless of their source.

**ACCESS TO ALL PAYMENT TEMPLATES
MANAGE USERS**

Access to view all payment templates credited by any users. Allows the user to create, edit, and delete users.

VIEW ALL RECIPIENTS

Allows user to see recipients created by any users. Requires generated transaction rights.

MANAGE RECIPIENTS

Master feature that turns on recipient navigation and allows the end user to create or edit recipient records within the customer. This right is required to create a template.

Transactions**ALLOW ACH COMPANY ENTRY
DESCRIPTION ENTRY**

The Company Entry Description field appears in Payment and Template workflows to support NACHA file formats with a Company Entry Description (CED) in the Batch Header record to describe the purpose or intent of a transaction.

Corporate

MANAGE COMPANY POLICY	Allows the user to make changes to the Company Settings found under the Administration menu.
INFORMATION REPORTING	Allows the user to view and create reports from existing reports.
MANAGE USER ROLES	Allows the user to create, edit, and delete User Roles.

Generated Transaction

ENABLE MULTI-TRANSFER	Includes the ability to create multiple internal funds transfers from one screen and save the set of transfers as a template. Users can select a single processing date or different processing dates for all of the transfers. However, a single batch ID will be associated to each set of transfers to streamline approval and reconciliation.
ENABLE MULTI-WIRE	Includes the ability for users to execute multiple domestic or international wire transactions from one screen and save the resulting set of wire transactions as a template. Users can select a single or different effective date for all of the transactions. However, a single batch ID will be associated for each wire to streamline approval and reconciliation. When enabled, user cannot use freeform wire option.
COMMERCIAL PAYMENTS	This feature controls the navigation menu for ACH/Wire found under the Pay & Transfer menu.

SSO

ENABLE PNC LOCKBOX	Allows users to access the lockbox online portal.
CSI E-STATEMENT SSO	This feature will enroll all accounts for E-statements and stop paper statements.

Custom Features

OUTSTANDING STOP PAYMENT REPORT	Outstanding stop payments details - Account Number, Check Number, Stop Payment Date, Payee, Amount, Expiration Date, and Reason. Available for current and previous day(s) in PDF or CSV.
ENABLE IPAY BBP ACCESS	This feature controls the navigation menu for Business Bill Pay found under the Pay & Transfer menu to allow users to access the business Bill Pay portal.
IPAY BUSINESS BILL PAY ADMIN	Allows the user to create, edit, and delete Bill Pay users.
